Tattoo Appointment Deposit Policy & Preparation Guidelines

Thank you for choosing Hotrod Tattoo. The entire staff at HRT is committed to providing you with the best possible experience, so please carefully read the following guidelines because these will ensure the process goes smooth. By continuing with the scheduling process and leaving your deposit indicates you understand and agree with the following;

1. Deposits are NON-REFUNDABLE. There is no pressure to schedule your appointment, so please take all the time you need to make an informed decision to work with Hotrod Tattoo and their representatives. We highly encourage you to ask as many questions and schedule a consultation with the tattoo artist of your choice prior to scheduling your appointment.
2. We understand that schedules change, in the event you need to reschedule we need 1 week notice to transfer your deposit. Tattoo Artists work based on commission only, and it is difficult to find a replacement for your appointment. If you need to reschedule your appointment with less than 1 week notice, We will work hard to fill your appointment time and in that case we can transfer your deposit. In the event we can not get your appointment time filled your deposit unfortunately will not be transferrable. If this situation arises we will need an additional deposit to make your new appointment.
3. If you are pregnant or nursing we can NOT tattoo you.
4. We understand your tattoo is very important, and we understand you might change your mind on your design- If this might happen to you we need at least 48 hours notice to change your artwork. We can make simple changes the day of the tattoo, but we don't want to take away time from performing your tattoo. Please reschedule your tattoo if you are not sure of your design exactly.
5. We will do our best to complete your tattoo in the time frame and price quoted. It is often that customers make adjustments in size and complexity, and this may require more time and additional costs. Our goal is to make your tattoo amazing, the more you invest financially and in time- "The more amazing your tattoo will be"
6. In order to make this a positive experience, we recommend that you get a good night's rest, eat a healthy meal, and drink plenty of water prior to your appointment. We will NOT be able to tattoo you if you are under the influence of DRUGS or alcohol. We can NOT tattoo you if you are sunburned or have over exposure to the sun in the area you are getting tattooed. Please refrain the week prior to your appointment
7. Our work areas have limited space, and we ask that you only bring a maximum of 2 guests with you. Artistry requires concentration and attention, too much noise and distractions ultimately can affect your tattoo. PLEASE NO CHILDREN...



Consent to TATTOO Procedure

I acknowledge by signing this agreement that I have been given the full opportunity to ask any and all questions which I might have about the obtaining of a "TATTOO" and that all of my questions have been answered to my full satisfaction. I specifically acknowledge I have been advised of the facts and matters set forth below and I agree as follows;

- If I have diabetes, epilepsy, hepatitis, hemophilia, HIV, AIDS or any other communicable disease, a heart condition or If I take medication which thins the blood I have advised my tattoo artist. I am NOT pregnant or nursing. I am NOT under the influence of alcohol or drugs.
- I DO NOT have medical or skin conditions such as but not limited to; acne, scarring (keloid), Eczema, psoriasis, freckles, moles or a sunburn in the aerate be tattooed that might interfere with the tattoo or procedure. If I have any type of infection or rash anywhere on my body, I will advise my tattooist.
- I acknowledge it is not reasonable possible for the representatives and employees of Hotrod Tattoo Inc to determine whether I might have an allergic reaction to the pigments or the processes used for my tattoo, and I agree to accept the risk that such reaction is possible.
- I acknowledge that infection is always possible as a result of the obtaining of a tattoo, particularly in the event that I DO NOT take proper care of my tattoo. I have received aftercare instructions and I agree to follow them while my tattoo is healing. I agree that any touch up work needed due to my own negligence will be done at my own expense.
- I realize that variations in color and design may exist between any tattoo as selected by me and as ultimately applied to my body. I understand that if my skin color is dark, the colors will not appear as bright as they might appear on lighter skin.
- I understand that if I have any skin treatments, laser hair removal, plastic surgery, or other skin altering procedures it may result in adverse changes to my tattoo.
- I acknowledge that a tattoo is a permanent change to my appearance and that no representations have been made to me as to the ability to later change or remove my tattoo. To my knowledge, I DO NOT have a physical, mental or medical impairment or disability which might affect my well being as a direct or indirect result of my decision to have a tattoo.

I acknowledge I am over the age of eighteen, and that I have truthfully represented to the Hotrod Tattoo Staff and my tattoo artist that the obtaining of a tattoo is by my choice alone. I consent to the application of the tattoo and to any actions or conduct of the representative and employees of Hotrod Tattoo reasonably necessary to perform the tattoo procedure.
